Should Malaysia diversify its solar export markets?

"The solar industry is a major part of the energy sector, which contributes nearly 20 per cent to Malaysia's gross domestic product (GDP). "As such, it is highly advisable for the country to diversify its solar panel export markets beyond the US due to the ongoing high tariffs," he told Bernama recently.

How many solar panels did Malaysia export in 2023?

According to Volza's Malaysia Export data, Malaysia exported 6,558 shipments of Solar Panel from Nov 2023 to Oct 2024 (TTM). These exports were made by 566 Malaysia Exporters to 878 Buyers, marking a growth rate of 269% compared to the preceding twelve months.
